The Review of general practice incentives: International evidence and literature review, commissioned by the Australian Department of Health and Aged Care, was completed by the CPHCE in collaboration with Centre for Future Health Systems and School of Population Health. This review was undertaken to inform the future design of payment models and performance incentives for primary health care as part of a broader reform of General Practice Incentives (Reform of General Practice Incentives Programs) which was announced in the 2023-24 Budget responding to recommendations of the Strengthening Medicare Taskforce report.
