

UNSW Business School Transfer Credit: Polytechnic Colleges, Singapore

Applicants to UNSW Business School who hold a completed Diploma from a polytechnic college listed below and meet CGPA requirements may apply for transfer credit to UNSW Business School programs.

- Ngee Ann Polytechnic
- Republic Polytechnic
- Singapore Polytechnic
- Temasek Polytechnic

Transfer credit

Applicants may be eligible for a maximum of 48Units of Credit / 8 courses of transfer credit. To ensure accuracy, all applications for transfer credit to UNSW Business School programs are individually assessed. To ensure your application is reviewed for transfer credit please upload supporting documentation such as course outlines at the time of application that include:

- Course code and title
- Course description
- Total hours for the whole course (e.g. How many lecture/tutorial hours per week and how many weeks per semester)
- Assessment weighting schedules (e.g. 30% mid-semester exam, 70% final exam etc.)
- Weekly topic schedule (i.e. Which topics were taught in each week)

Optional components that may be required:

- Textbook materials used
- Credit units for the course and total credit units for a full-time student per semester

Bachelor of Commerce Transfer Credit

Applicants with a Business or Business-related diploma may be eligible for up to 48 Units of Credit/8 courses of transfer credit into the <u>Bachelor of Commerce</u>. Applicants with a non-business Diploma may be eligible for a reduced volume of transfer credit.

Transfer credit to the Bachelor of Commerce may be a combination of integrated first year courses, electives and/or courses that count towards a major, and general education program requirements. Students who receive transfer credit for a minimum of 24 UOC/4 courses of integrated first year courses will also be awarded credit for <u>COMM0999 myBCom Blueprint</u> (0 UOC) and required to attend a **myBCom Bootcamp to** welcome transfer students commencing in the Bachelor of Commerce. Attendance is **compulsory** for all transfer students. Delaying your attendance at the myBCom Bootcamp may delay the completion of your degree.

Important notes

- Entry requirements are subject to change and the CGPA above will be reviewed on a regular basis.
- We recommend that you review your preferred program structure in the <u>UNSW Handbook</u> to understand how to structure your course enrolment for the major/s you wish to study. The Business School <u>Undergraduate Progression Planner</u> can help you to map out your course choices.
