Summary of the Course

The systematic study of politics has a long history, stretching back some two and a half thousand years to the ancient Greeks. Over the last century, however, it has become institutionalised and professionalised and, as the disciplinary name Political Science suggests, has sought to put the study of politics on a footing comparable to the aims, methods, and conventions presumed integral to the natural sciences. Yet the possibility, desirability, and even meaning of a “science of politics” are controversial issues. This course examines fundamental questions about what political knowledge is and how it is acquired the 'art', craft of political science, that can be learned, practiced and improved over times. This goal is achieved by reading and engaging in careful study of several seminar works in contemporary political science. In almost every week, we study a well designed and effectively executed research work as an example of how the 'art' of political science is practiced in various branches of the discipline, including normative, formal and empirical studies.

Course Learning Outcomes

1. Identify and outline the contested character of approaches to studying and analysing political phenomena and the different visions that the discipline of political science has of its mission
2. Evaluate a variety of advanced debates on and approaches to the study of politics, informed by a self-reflexive awareness of the reasoned views of others
3. Locate, prioritise and apply appropriate methodology and methods to the study of Politics in a sophisticated and persuasive manner
4. Design your own research project with proper methodology, practical methods, and pool of information.

Teaching Strategies

We see UNSW student learners as participants in the production of knowledge and we pursue the implementation of a curriculum responsive to each student's individual needs. The design of this course is motivated by a desire to foster the skills of independent learning, research and critical thinking.

The course is offered as a 3-hour seminar that is supplemented with independent study (reading, note-taking, research). Seminars allow you to discuss questions, themes and issues arising from your independent study and research, as well as providing the opportunity to engage in productive discussion with your peers and to participate in a range of structured learning activities, including group/pair/individual analytical work, formal and informal debates and mini-projects.

Assessment 1: Research design

Assessment length: 800 words

Choose a topic of research and an approach covered in the course. Draw up a research design (800 words) that has at least the following components: research question, theoretical context, methodology, research tactics and steps. You will receive written feedback, and a numerical grade within two weeks of submission through Moodle

Assessment 2: Review Essay

Assessment length: 1500

Due date: 17/07/2022 11:59 PM

Students will write a review essay (1500 words) explaining the theoretical context of the chosen research topics. The aim of this assessment is to encourage students to master a specific art and method of political scientific research. Students will receive a mark and formal comments within 2 weeks.

This assignment is submitted through Turnitin and students can see Turnitin similarity reports.

Assessment 3: Research Paper

Assessment length: 3000

Due date: 14/08/2021 11:59 PM

The essay requires you to demonstrate engagement with the core themes and issues raised in the course and your ability to carry out a research construct a persuasive and well-evidenced argument. The word length of the essay is 3000 words. You will receive written feedback, a completed rubric, and a numerical grade within two weeks of submission through Moodle. This is the final assessment of the course.

Academic Honesty and Plagiarism

Plagiarism is using the words or ideas of others and presenting them as your own. It can take many forms, from deliberate cheating to accidentally copying from a source without acknowledgement.

UNSW groups plagiarism into the following categories:

Copying: Using the same or very similar words to the original text or idea without acknowledging the source or using quotation marks. This includes copying materials, ideas or concepts from a book, article, report or other written document, presentation, composition, artwork, design, drawing, circuitry, computer program or software, website, internet, other electronic resource, or another person's assignment without appropriate acknowledgement.

Inappropriate paraphrasing: Changing a few words and phrases while mostly retaining the original information, structure and/or progression of ideas of the original without acknowledgement. This also applies in presentations where someone paraphrases another's ideas or words without credit and to piecing together quotes and paraphrases into a new whole, without appropriate referencing.

Collusion: Working with others but passing off the work as a person's individual work. Collusion also includes providing your work to another student for the purpose of them plagiarising, paying another person to perform an academic task, stealing or acquiring another person's academic work and copying it, offering to complete another person's work or seeking payment for completing academic work.

Inappropriate citation: Citing sources which have not been read, without acknowledging the "secondary" source from which knowledge of them has been obtained.

Duplication ("self-plagiarism"): Submitting your own work, in whole or in part, where it has previously been prepared or submitted for another assessment or course at UNSW or another university.

Correct referencing practices
