## Backing research



UNSW researchers are driven to spark conversations, develop solutions, and lead action to address the most pressing challenges of our time, locally and globally. Directing your gift in your will to an area of research means you will be lending your support to a community that is actively engaged in building a safer, fairer and more prosperous world.

A Sydney-man diagnosed with Multiple System Atrophy (MSA) turned the tragedy of his own diagnosis into hope for future generations with a gift in his will to Australia’s only MSA lab, led by UNSW’s Dr Michael Janitz. His gift will support ongoing research into the detection and treatment of the rare neurodegenerative disease.

## Funding a program



Turning knowledge into action has always been a priority for UNSW. By leaving a gift in your will to one of UNSW’s many programs, you help to ensure the knowledge generated within the University has a real-world impact among those who stand to benefit from it the most.

A beloved community GP made a generous gift to help the Kirby Institute train local doctors to diagnose and treat hepatitis C. His gift has made hepatitis C treatment more accessible, particularly in rural and regional communities, and taken pressure off an overburdened hospital system.

## Contributing to a centre



To meet the challenges of the 21st century, it is critical that we work together across disciplines, across borders, and across a network of allies in research, government and industry. Choosing to invest in the powerful partnerships led by the University means supporting the work of a world-leading community of changemakers.

In honour of her much-loved husband, a Sydney woman has left a gift to support the launch of the National Comprehensive Dementia Centre (NCDC). # Making the legal and financial arrangements

Having decided you want to leave a gift in your will, it is important that you get the appropriate legal and financial advice. Your lawyer will help you update your will, making sure your loved ones are looked after according to your wishes and that your gift to UNSW is clearly and accurately expressed. They will also explain the different ways the value of a gift can be described, for example:

- A specific gift is a specific sum of money or a particular gift of property or shares.
- A residual gift is the amount that remains in your estate after all other gifts and costs have been distributed.
- The residual of your estate can be given to someone in whole or shared as a percentage among a number of different beneficiaries.

It is important to note that these options may have different tax impacts, depending on your situation. Your lawyer or financial adviser will be able to explain these to you.

## Your next steps

Your interest in supporting the University through a gift in your will is evidence of your generosity, your values and your vision for the future. It speaks of your enduring commitment to the people and ideas that matter most to you and your willingness to make sure they get the support they need for many years to come.
