Program and Course Terminology

Terminology	Definition
Integrated First Year Courses	Students must take 48 UOC of the integrated first year courses.
Commerce Co-op Specialisation	A sequence of approved courses (84UOC) in an approved Co-op discipline stream offered by the UNSW Business School, containing at least 18UOC at level 3. For majority of majors, students will complete 42 UOC in specified disciplinary courses outside the core and 36 UOC Industry Training.)
Industrial Training Experience	These courses account for 36 UOC. Students complete 3 industrial training experience courses within the area of their co-op scholarship, with each course worth 12 UOC.
Business School Electives	Students must complete Business School Electives to complete a minimum of 132UOC of courses within the Business School. Students are free to use these UOC to complete a second Commerce major or minor, however they need to be mindful of the program level 1 limit when making their selection. GEN courses cannot count as Business School Electives.
Free Electives <u>OR</u> Second Major OR Minor	Students can take up to a maximum of 48 UOC of the following courses. Students are free to use these UOC to complete courses from any Faculty or to complete a second Major or a Minor. However, they need to be mindful of the program limit on Level 1 courses (72 UOC) when making their selection. <i>NOTE: GEN coded courses cannot count as a Free Elective.</i> Student undertaking certain double majors may not have any free electives.

Double Majors	Students completing a major sequence with courses in common which are not integrated 1st year course may only count the overlap towards one major and must replace this course within the other major with a major elective of the same level or higher.
General Education	Account for 12UOC (2 courses) and are to be taken outside the UNSW Business School. Please note: Students enrolled in programs within the UNSW Business School cannot take General Education courses offered by the UNSW Business School (i.e. GENC code). These restrictions also apply to the following courses: CDEV2000 Creating Your Career: Employability for the Future, CDEV3000 Practice of Work, CDEV3001 WIL Experience Term, DIPP1111 Introduction to Leadership and Professional Practice, GENL2021 Introduction to the Australian Legal System, GENL2032 Cyberspace Law 2.0.
myBCom	Students need to complete three non-credit bearing myBCom professional development elements including myBCom Blueprint (COMM0999), myBCom First Year Portfolio (COMM1999) and myBCom Graduation Portfolio (COMM3999)
Final Year Synthesis	Students must complete either a 6 UOC Synthesis of Learning Course, or a 0 UOC Synthesis Experience. Students who complete a Synthesis course that is also a Work Integrated Learning course within a major, will meet a major elective, WIL and Synthesis requirement.
Level 1 limit	The maximum level one limit in this degree is 72UOC (12 courses), excluding General Education courses.
Overall Program UOC	Students must complete a minimum 192 UOC across program requirements.
