## Program and Course Terminology

Terminology	Definition
<b>Integrated First Year Courses</b>	Students must take 48 UOC of the integrated first year courses.
<b>Business Co-op Honours Major</b>	<p>Students complete a co-op honours major (96 UOC) in the disciplinary area of their Co-op scholarship. (Note: Currently Finance is the only major offered in this program.)</p> <p>The co-op honours major must contain at least 18 UOC at level 3 and 48 UOC at level 4. (Note that the 96 UOC includes the integrated 1<sup>st</sup> year course COMM1180). This means that, for the majority of majors, students will complete 90 UOC in addition to COMM1180.</p> <p>On satisfactory completion of the requirements of this program, students will be awarded a class of honours. The class will be dependent on the weighted average mark (WAM) of the level 4 courses.</p> <p>Class 1: WAM of 85 and over</p> <p>Class 2(1): WAM of 75 to less than 85</p> <p>Class 2(2): WAM of 65 to less than 75</p> <p>Class 3: WAM of 50 to less than 65</p>
<b>Industrial Training Experience</b>	These courses account for 36 UOC. Students complete 3 industrial training experience courses within the area of their co-op scholarship, with each course worth 12 UOC.
<b>Business School Electives</b>	Students must complete Business School Electives to complete a minimum of 132UOC of courses within the Business School.

<b>General Education</b>	Account for 12UOC (2 courses) and are to be taken outside the UNSW Business School. Please note: Students enrolled in programs within the UNSW Business School cannot take General Education courses offered by the UNSW Business School (i.e. GENC code). <b>These restrictions also apply to the following courses: CDEV2000 Creating Your Career: Employability for the Future, CDEV3000 Practice of Work, CDEV3001 WIL Experience Term, DIPP1111 Introduction to Leadership and Professional Practice, GENL2021 Introduction to the Australian Legal System, GENL2032 Cyberspace Law 2.0.</b>
<b>myBCom</b>	Students need to complete three non-credit bearing myBCom professional development elements including myBCom Blueprint (COMM0999), myBCom First Year Portfolio (COMM1999) and myBCom Graduation Portfolio (COMM3999)
<b>Final Year Synthesis</b>	Students must complete either a 6 UOC Synthesis of Learning Course, or a 0 UOC Synthesis Experience.  Students who complete a Synthesis course that is also a Work Integrated Learning course within a major, will meet a major elective, WIL and Synthesis requirement.
<b>Level 1 limit</b>	The maximum level one limit in this degree is 72UOC (12 courses), excluding General Education courses.
<b>Overall Program UOC</b>	Students must complete a minimum 192 UOC across program requirements.
